Please be informed that the National Privacy Commission (NPC) is suspending the launching of its **eRehistro system** this month of June to make way for a complete solution that integrates all the services related to data privacy compliance.

With this, the NPC is **extending the validity** of all existing Certificates of Registration issued in 2019 and 2020 to **MARCH 8, 2022**.


In the meantime, they will continue with their manual registration process. 
